Introduction

The Division of Licensing & Protection (DLP), of the Vermont Department of Disabilities, Aging & Independent Living, is responsible for regulating care facilities throughout the state. On the following pages is a listing of these facilities in Age Well's service area. Licensed Facilities outside of Age Well's four-county area can be found on the Division's website (www.dlp.vermont.gov/). Facility types include:

Nursing homes (NH)

These facilities provide care for people who need nursing, medical, rehabilitation, or other special services. They are licensed by the State and may be certified to participate in the Medicaid and/or Medicare programs. Certain NHs may also meet specific standards for subacute care or dementia care.

Residential care homes (RCH)

RCHs are state-licensed, group-living arrangements designed to meet the needs of people who cannot live independently and usually do not require the type of care provided in a NH. When needed, help is provided with daily activities such as eating, walking, toileting, bathing, and dressing. RCHs may provide NH level of care to residents under certain conditions. Daily rates at RCHs are usually less than rates at NHs.

Residential care homes provide nursing overview, but not full-time nursing care. Some homes are also designated as Enhanced Residential Care (ERC) providers, allowing the facility to designate a number of beds that can be occupied by residents that need a higher level of care.

Assisted Living Facilities (ALF)

These state licensed residences combine housing, health, and supportive services to assist resident independence and aging in place. At a minimum, ALFs shall offer a private bedroom, private bath, living space, kitchen capacity, and a lockable door. ALFs must meet the Licensing Regulations in addition to the RCH Licensing Regulations which are designed to protect the welfare and rights of residents and ensure that they receive quality care.
